Nominations will be reviewed by a panel of faculty and staff of Jarvis Christian College, along with a select group of external constituents. Winners will be chosen by **March 1, 2019**. The family and nominator of the awardee will be notified the week of **March 4, 2019**. Formal announcement of honorees will take place during the awards program on **March 23rd**.

Nomination Categories: (Select <u>one</u> category per nomination.)

 \Box **Education and Academics** – The award honors an individual who has positively impacted the quality of education or made significant contributions to the academy. Specifically, the honoree should possess a track record of excellence in teaching and academic activities, and demonstrates a commitment to students, the profession, and/or JCC. Nominees may be teachers, professors, counselors, librarians, administrators, school board members or educational advocates associated with public or private institutions at all levels of education.

 \Box **Government, Politics and Advocacy** – The award honors an individual who has impacted public policy at the local, state or federal level; preferably, policies that have positively impacted the survival, growth and long-term viability of JCC. The honoree may also have made significant contributions through elective office, community service or advocacy.

 \Box **Philanthropy** – The award honors an individual who has made a significant investment in the prosperity and advancement of JCC by providing financial resources, access to funding sources or opportunities, time and volunteer efforts, or labor for construction projects and maintenance of JCC's physical plant. The honoree must also have evidence that he or she volunteers on behalf of JCC and encourages philanthropy in others.

□ Leadership, Community Service and Civic Engagements – The award honors an individual who has, through his or her community service, significantly impacted their community and, as a result, increased awareness of JCC and/or enhanced the College's reputation. The award further recognizes individuals who have demonstrated outstanding leadership in their careers or professions; whose work has contributed to the advancement of their community, profession, or JCC; and whose commitment to JCC has remained strong for many years.

□ **Business and Entrepreneurship** – The award honors a JCC graduate or former student who has gained stature, prominence and success in the area of business or entrepreneurship and, as such, has brought recognition and awareness of JCC. Judging criteria includes an assessment of financial performance, strategic direction, product or service innovation, and company leadership including personal integrity and risk-taking.

 \Box John D. Mangram Religion and Ministry – The award honors an individual who has made highly significant contributions to religious and spiritual life at Jarvis Christian College and in their communities. The recipient of this award displays a love and understanding of their Christian faith and articulates a commitment, not only to performing acts of service, but to living a service focused life. Service is the selfless giving of oneself to benefit others with no expectation of recognition, reward or acknowledgement.
