**Sexual assault, to include relationship violence, is a crime, and a violation of JCU's Title IX Policy.**

## Sexual Assault

Any nonconsensual sexual act even when the victim lacks capacity to consent.

Sexual acts include:

- Forcible rape
- Forcible sodomy
- Sexual assault with an object
- Forcible fondling

## Dating Violence

Violence, on the basis of sex, committed by a person, who is in or has been in a romantic and intimate relationship with you. Dating violence includes, but is not limited to, sexual or physical abuse or the threat of such abuse.

## Domestic Violence

Violence, on the basis of sex, committed by a current or former spouse or intimate partner, by a person with whom you share a child in common, or by a person who is or has cohabitated with you as a spouse or intimate partner. \*\*To categorize an incident as Domestic Violence, the relationship between you and the aggressor must be more than just two people living together as roommates. Must be current or former spouses or have an intimate relationship.

## Stalking

Engaging in a course of conduct, on the basis of sex, directed at a specific person, that would cause a reasonable person to fear for their safety, fear for others'

## Force

Physical violence and/or physical imposition to gain sexual access.

## Coercion

Unreasonable pressure for sexual activity.

## Incapacitation

When someone cannot make rational, reasonable decision because they lack the capacity to give knowing/informed consent.

## Consent

Knowing, voluntary, clear permission, by word or action, to engage in sexual activity.

- Consent can be withdrawn, if reasonably and clearly communicated. Once withdrawn, sexual activity must stop immediately.
- A person cannot consent if: **disoriented, helpless, asleep, or unconscious** (for any reason, including alcohol or drugs). A person cannot give consent if force, expressed or implied, is used, or if duress, intimidation, threats, or deception is used.
